#### B Cllr Shovelton

The councillor is experiencing issues in gaining a response from the Cornwall Open Access Team to give him the information he needs to progress improvements to access and signage. ACTION Clerk to liaise with Cllr Seeva to speed up the response time.

#### C Cllr Frances Lewis

The councillors reported that the St Keynines Dog Group had met recently to discuss proposals to create a dog paddock in the parish that could be used for outdoor exercise. They also have plans to offer a voluntary service for residents who were unable to exercise their dogs. The group is also willing to erect temporary signage at Jubilee Park that would set up council rules on dog exercise. This would take place once the parish council had erected a fence around the play area. The Chair reminded St Keynines that the council would reimburse them for any costs of approved signage, and encouraged them to apply for a small grant if they needed some financial support to get their plans moving.

ACTION Clerk to contact Outdoor Play People to expedite installation of the fence.
