135/2019 Chair's Agenda Items

A Community Governance Review

Reported that on the Electoral Review Panel meeting held in Truro 22 October 2019, the Panel had voted to support all the changes proposed in the submission, that: the settlement of Trewidland moves into St Keyne boundary, the number of councillors will increase by two and that the name of the combined parish be St Keyne & Trewidland Parish Council. These proposals are expected to be signed off by Cornwall Councillors on December 10, after which they will be out for consultation until March 2020. Details will be published as they are received.

B Defibrillator Training 15 October 2019

The Chair thanked the fifteen residents and councillors who attended the recent training. The new cabinet will be fitted shortly.

C Financial report from the Village Hall

Councillors discussed the recent accounts and noted their contents.

D Parking management at Village Hall
