57/2021 Chair's Welcome & Housekeeping

The Chair welcomed all councillors to the annual meeting of the new St Keyne & Trewidland Parish Council. She explained that the meeting was taking place under current Covid-19 regulations which included a record of attendees that is available to NHS Track & Trace if needed.

58/2019 Elections

The Chair invited parish councillors to propose a new Chair for the forthcoming civic year. There being no proposals, Cllr Lewis proposed herself. It was **Resolved** to elect Cllr Sally Lewis as Chair. Seconded Cllr Higgs. All agreed.

59/2021 Public Participation

Cllrs Pascoe and Toms both introduced themselves and explained that they were delighted to have been elected to represent their respective wards in the new parish. They will be attending future council meetings and commit themselves to supporting the council and representing their best interests in Truro.

Clerk reported that he had that evening received an email from Richard Dorling giving apologies for not attending the meeting due to a clash with another meeting. Clerk explained that he had not received a copy of Mr Dorling's Declaration of Acceptance of Office, and that in accordance with the 1972 Local Government Act s83, he has vacated his office. The options open to councillors are that: they confirm the vacancy and move to co-option (see Item 66 below) or that they extend the time frame for the delivery of the Declaration to the next public meeting. It was **Resolved** to confirm the vacancy. Proposed Cllr Higgs. Seconded Cllr Fran Lewis seconded. All agreed. **Action**: Clerk to inform Richard Dorling, Cornwall Council Democratic Services.
