The Chair welcomed PCSO Steve Edser to the meeting and invited him to address councillors on matters of community safety.

Cornwall Councillor Jane Pascoe reported that: the Community Network Panel had met via Zoom on Monday last which included a discussion on local priorities (see Item 105C below); the Economic Growth & Development Overview & Scrutiny Committee had met on 5 October to agree to a pilot scheme that would trial 20mph speed limits in selected villages across the county. Cllr Armand Toms has visited the temporary camp at Landlooe and the owners have confirmed they will submit a formal application for planning consent to make permanent changes to their site; is aware of the increase in evictions by landlords wanting to rent out their properties to holiday visitors (and asks that any problems with evictions be referred to him); reminds residents that free parking in Cornwall Council car parking begins on 4 December.

The Chair welcomed PCSO Steve Edser to the meeting and invited him to address councillors on matters of community safety.

Speeding vehicles

Councillors were concerned about the increase in the numbers of vehicles that seemed to be speeding dangerously in both St Keyne and Trewidland. With more people using home delivery for online shopping, delivery drivers who were not familiar with the area were causing problems on narrow roads. These problems affect older people, dog walkers and horse riders as much as other drivers.

Steve suggested that residents should be encouraged to install dashcams in their cars and record vehicles they met on the roads. Video footage can be uploaded at the Devon & Cornwall Police website as evidence and the questionnaire on the site offers the equivalent of a statement of facts in the complaint.

Horse riders who are experiencing problems with speeding vehicles are also encouraged to use headcams when riding out.

Steve offered to visit Trewidland and make a risk assessment of the area and with a view to inviting the Community Speedwatch team to monitor the road.

Any residents or councillors who might be interested in joining the Speedwatch team are asked to contact Steve directly (contact details below)

The British Horse Society is running a safety campaign at the moment.

In the meantime, he suggests that people walking along the road take these safety precautions:

Walk on the right hand side of the road to face oncoming traffic

Wear hiviz if you can so that other road users can see you

Choose a route where there are opportunities to step back off the road if vehicles are approaching

If you do observe a vehicle that is speeding dangerously, take their registration number and record the time, date and location. Please report this either by phoning **101** or via the police email **101@dc.police.uk**
