# Minutes 14 June 2023

**Present:** Cllrs Kevin Shovelton (Chair), Angela Woodman, Lindsey Ellis, Jonathan Ellis, Sally Lewis, Alex Blackwell, Mark Featherston; Sarah Whiting. There was one member of the public present. Also, present Cornwall Cllrs Jane Pascoe; Armand Toms, Parish Clerk John Hesketh.

### 67/2023 Chair's Welcome & Housekeeping

Cllr Shovelton welcomed councillors and set out the format for the closed session that would interview candidates for the vacant seat in St Keyne ward.

## 68/2023 Apologies

None received.

#### 69/2023 Declarations of interest

No declarations of interest made, or dispensations requested.

#### 70/23 Closed Session

Councillors interviewed two candidates for the remaining vacancy on the parish council, and **Resolved** to co-opt Mr Roger Cook to represent the ward of St Keyne. Proposed Cllr Shovelton. Seconded Cllr Lewis. All agreed. Mr Cook signed his Declaration of Acceptance of Office. **Action**: Clerk to inform Cornwall Council and arrange induction.

## 71/2023 Public Participation

Cornwall Councillor Jane Pascoe reported that: the inaugural meeting of the new Community Area Partnership was held on 6 June and 23 out of 29 parishes attended; Cllr Pascoe was elected Chair; two sub-groups were agreed (Highways and Funding) and three working groups (Transport and Connectivity, Economic Growth and Development, Climate Action and Nature Recovery); the meeting had agreed a letter to the Department for Transport challenging their recent decision to postpone works on the A38; plans for a new integrated services hub at Liskeard Cattle Market would see a net gain in parking spaces with priority parking for residents and shoppers; because of the hot weather, refuse collections may take place earlier in the day – please put your waste out the night before; Liskeard Show takes place on 8 July 2023. Councillor Toms reported that: had visited the site of a new geothermal generator at Redruth; lobbying to restrict applications for retrospective planning applications. Cllr Featherston asked about proposed roadworks and Lodge Hill and the impact this might have on access to the parish. Cllr Pascoe explained that the budget for those works was restricted and that no work was planned for the foreseeable future – she would monitor the situation and report back.

Application PA23/03519

Proposal Listed building consent for converting the first floor small bedroom into a family bathroom with a shower, basin and toilet and to fit a conservation style wall vent in the west elevation to service the new bathroom.

It was **Resolved** to support this application. Proposed Cllr Blackwell. Seconded Cllr Whiting. All agreed. In making their decision, councillors noted the details of the Heritage Impact Assessment and the minimal impact that the proposals will have on the exterior of the property and internal changes.

## Application PA23/04147

Proposal Erection of an agricultural shed and solar panels

Location Lean Park Farm Horningtops Liskeard Cornwall

Councillors **Resolved** not to support this application. Proposed Cllr Whiting. Seconded Cllr Lindsey Ellis. In making their decision, councils noted contradictory details in the Design & Access Statement. The application is for an agricultural shed and the D&A explains the shed would be used 'to house machinery and farming equipment on land' but the site is also described as 'a country home in a private setting with outbuildings' There is no evidence from the application form, the D&A statement or recent publicity from Savills Estate Agents that this is a working farm that requires an agricultural shed to house farm equipment. The design and materials proposed are not

appropriate for a building in close proximity to the Grade 2 listed buildings in the vicinity, and the scale of the proposal is overbearing in relation to adjacent properties.
